CFI Statutory Requirements

I have been on the statewide list as an approved Child and Family Investigator (CFI) since 2014, and since going on the statewide roster, I have been appointed in over 1100 cases. Over 50% of the cases I have worked on involved allegations that include one or more of the following issues: domestic violence, substance abuse, child abuse or child sexual abuse. The families I have worked with include traditional and non-traditional family configurations, including Grandparent caregivers, three-party cases involving Grandparent(s) and Biological parent(s), Kinship or Stepparent caregivers, LGBTQIA+ parents/caregivers, Neurodiverse parents and/or children, and Incarcerated parent(s). Some of the children I have worked with identify as non-binary, transgender, are exploring their gender identity, or have been in active transition.

As required by CJD 04-08, I have completed greater than the twenty hours of initial training and greater than fifteen hours of ongoing training every five years, in the areas of (I) child sexual abuse; (II) physical abuse; (III) emotional abuse; (IV) coercive control; (V) implicit and explicit bias, including biases relating to parties with disabilities; (VI) trauma; (VII) long-term and short-term impacts of domestic violence and child abuse on children; and (VIII) victim and perpetrator behavioral patterns and relationship dynamics within the cycle of violence. Although I am qualified to conduct domestic violence screenings using the Ontario Domestic Assault Risk Assessment (ODARA) model, I do not provide such screenings as part of my CFI work. In addition to being licensed as an attorney in California (1990) and Colorado (2015), I hold a Master of Social Work degree and have worked as a mental health professional in clinical settings where I worked with families and children in a non-forensic context.
